

**Appendix 1**  
**Local Government Act 1894**

St Mary's Church approached Haverhill Town Council for financial assistance to install a roof alarm, to deter thieves from stealing the lead off the roof, something that has happened to many historic churches in Suffolk. However, the National Association of Local Councils, NALC, issues legal advice to us that:

Section 8(1)(i) and (k) of the Local Government Act 1894 gives parish councils the power:

“to execute any works (including works of maintenance or improvement) incidental to or consequential on the exercise of any of the foregoing powers, or in relation to any parish property, not being property relating to affairs of the church or held for an ecclesiastical charity; and... to contribute towards the expense of doing any of the things above mentioned, or to agree or combine with any other parish council to do or contribute towards the expense of doing any of the things above mentioned”.

I do not think that section 8 permits the council to contribute to the purchase of a roof alarm. I think that installing a roof alarm is caught by section 8 when the property relates to affairs of the church. The General Power of Competence permits a council to do anything an individual can do unless specifically prohibited by legislation, like section 8. Any limitation that applied to a local authority before the General Power was introduced, continues to apply.

It is therefore my view that the council cannot assist the church by providing funds for the purchase of a roof alarm.

The Town Clerk disagrees with this interpretation of the Act as an absolute restriction on parish councils and is aware that many other parishes are frustrated too. The cost to the local community through the diversion of funds for many years to replace the lead on church roofs, and to everyone through increased insurance premiums, is a real issue and the fact we have to sit by and do nothing is frustrating and looks bad to voters. However, we now have a new interpretation, by the government itself.

July 2017: Sent from Marcus Jones MP, Minister for Local Government, DCLG to Brympton Parish Council, Somerset.

Having considered this issue further, I am now able to provide you with the more detailed response that I promised. It is my view that S.8(1)(i) of the Local Government Act 1894 does not constitute an absolute restriction on a parish council's ability to undertake or fund building, repair or improvement work on church property. Instead, the restriction relates only to the activities a council may undertake when exercising the specific power set out in that Act.

It is my view that a council with the general power of competence would be able to provide funding of the kind that Mrs James sets out in her letter of 11 May 2016. This is due to S.1(5) of the Localism Act 2011, which, when setting out the details of the General Power of Competence, states that "The generality of the power conferred by subsection (1) ("the general power") is not limited by the existence of any other power of the authority which (to any extent) overlaps the general power".

However, as you know, I am unable to give an authoritative interpretation of legislation, as only the courts are empowered to do this. I therefore you that you and your constituent will find this informal advice helpful, but they may wish to seek their own legal advice before taking any action."

If NALC simply accept this interpretation, then parishes are free to support their community in this matter. Churches are used as community buildings for non-religious purposes more and more. Whilst the 1894 Act was put in place to protect civil funds from being swallowed up by the church, that was Victorian England which was dominated by the church. The motion, to be put at the Suffolk Association of Local Councils' AGM, would require NALC to rethink their interpretation. **Councillors are asked to consider approving submitting the motion for debate at the SALC AGM.**
