Mayor B McLatchy welcomed everyone to the meeting and advised members of the public attending that the meeting was being recorded. She also noted that Borough and County Councillor Tim Marks was in hospital and on behalf of all the meeting wished him well.

C15 <u>Apologies for Absence</u>

/118 The above apologies were noted.

C15 Declaration of Interests and requests for dispensation

/119 No declarations of requests had been received.

C15 <u>The minutes of the Full Council meeting held 21st July 2015</u>

/120 The meeting agreed these were a true record.

C15 <u>Matters arising not on the agenda</u>

/121 a) C14/030b Haverhill Clock

The clock structure is in situ and the clocks are being fitted on 30th September in readiness for the official ceremony on 2nd October.

C15 Haverhill Response to the Migrant Crisis

/122 The Mayor advised that the Suffolk role in accommodating refugees was being co-ordinated by the County Council and families may or may not be allocated to St Edmundsbury, so it was not known what, if any, help might be required within the town. Councillors agreed that as soon as it was known whether the town needed to respond, a meeting should be called to

discuss this matter. It was noted that assistance might be given by Haverhill even if resettlement was in other towns.

C15 Consultation with young people regarding a Youth Hub

/123 The Clerk advised that he had been given a brief overview of the results of the consultation and would be given the full results during October. The 'headlines' were that young people were interested in activities such as the skate park and proposed pump track. They were looking for somewhere to hang out and somewhere to produce music. They appeared to find access to information was not a problem for them. This suggested that the assumption for a hub where access to information and services would be the primary purpose was not necessarily still valid.

Once the full consultation results were received, these would be reviewed and proposals worked up, before returning to the Council with recommendations.

C15 <u>Reports from the Police, borough and County Councillors and the</u> /124 <u>PUBLIC FORUM</u>

The meeting received reports from the Police and Borough/County Councillors on issues pertinent to Haverhill and the Public Forum. See Appendix 1 for Details.

Councillors C Turner and W Yang left the meeting

C15 <u>Haverhill Corn Exchange</u>

/125 Members again expressed concern at the state of the building and the need for the Conservation officer to get involved in some enforcement action. Councillor Byrne advised that one group who had been considering converting the building for flats and a meeting room had concluded that this was not a sustainable development and pulled out. Another group have similar plans but their business plan is unclear at this stage.

Councillor J Crooks asked that a building survey be carried out on the building to establish what works were needed, and the cost, of stabilising the state of the building. This would be an agenda item on 20th October. Councillor Byrne will ask the group which recently pulled out from converting the building are able to share information on its state.

C15 <u>One Haverhill</u>

/126 Councillor D Roach proposed, seconded by Councillor J Burns, the following motion:

To provide from within town council resources administrative support to the Chair of ONE Haverhill to include servicing meetings, issuing agendas, minute-taking, responding to press enquiries and FOI requests and keeping the website up to date. The Town Council would continue to provide banking and financial administration to ONE Haverhill whilst project work would continue to be done by partners, including project-related PR.

In return for doing these, the Town Council requires that the Terms of Reference for ONE Haverhill are amended at the next Board meeting in regard to:

Transparency – ONE Haverhill adopts, for a trial period of 4 consecutive board meetings, the borough council meeting system of Part 1 in public & Part 2 in private for any personnel or commercially confidential business to

be transacted. This will include the ability of members of the public to ask questions, record the public part of the meetings via any medium and publicly report on such meetings. At the end of that period, the 5th meeting can decide whether to continue in public or revert to private meetings. Also that ONE Haverhill responds to public FOI requests in an honest and open manner.

Representation – that ONE Haverhill adopts the proposals at the workshop on 17th September to increase Public Health and Town Council representation and that statements made in the name of ONE Haverhill represent the majority of its members' views. Also that no voting in absentia is permitted.

Partnership – That ONE Haverhill adopts the proposals at the workshop to change its name to ONE Haverhill Partnership to clarify that it is a forum for working together to create better outcomes, not a standalone organisation in its own right.

Chair – Given the incumbent's intention to step down, that the ONE Haverhill Partnership rotates the chair of the partnership at least once every 12 months and includes all voting members of the partnership in the selection process for Chair.

AND

That should the Town Council's offer of assistance and request for both proper transparency and better representation of the community on the ONE Haverhill Board be rejected, that the Town Council would be unable to continue to support ONE Haverhill and therefore subsequently and regretfully would withdraw from the partnership. **RESOLVED**

C15 Borough Review of Working Parties

/127 Councillor J Burns proposed, seconded by Councillor M Byrne, that the following response be submitted:

Haverhill Town Council limits its response to the Haverhill Area Working Party (HAWP) only. What representatives of other areas wish to state about AWP covering their location is a matter for them. A one-size-fits-all approach is unnecessary.

Haverhill Town Council objects to the proposal to scrap HAWP. It does so upon the following basis, in reference to the questions asked in the review:

• the possibility of building upon the existing arrangements of the ONE Haverhill Partnership (allowing for its current review of governance) to establish a new locality arrangement in Haverhill, working with ward members and locality officers:

There is no alternative forum for elected Members from all levels of local government to discuss issues.

ONE Haverhill is not an appropriate alternative – currently it is not even meeting in public. It should only be interested in adding value to the programmes of public bodies at an operational level by looking for common strands within the work of public, private and not-for-profit sectors and

building on potential win-win scenarios. A good example is that the Borough made a policy decision to create a Town Centre Masterplan. The operational delivery of the consultation stage was enhanced by the involvement of ONE Haverhill partners.

By contrast, HAWP is a public forum for discussing policy-level local authority strategy as it impacts a significant population – it isn't designed to be a delivery agent.

• possible alternative models of liaison and engagement on issues relating to Haverhill (if applicable):

A criticism levelled at AWP is that they are officer-intensive and therefore expensive. This appears to the Town Council to be much more about the location of meetings and the breadth of the agenda than about the principle of Councillors meeting. There is also a suggestion that too few recommendations come from the AWP. This is also about the agenda – Town Council representatives on HAWP do not recall any 'failure' to form a recommendation and can see no examples in the minutes. We think that there were just very few requests for a recommendation. Particularly the last few agendas appear to have been mostly verbal updates from officers.

The Terms of Reference can be amended if necessary. It needs only limited servicing and with shorter, more focussed agendas can avoid the need for too many officers to be present. It could be held at West Suffolk House on a day when Councillors need to be there anyway. It could broaden membership to include all elected members at each level of local government, akin to a "Grand Committee" which could feed back to each appropriate authority.

• The Haverhill Area Working Party before the last election:

HAWP has not even met since the election. There is a significant change in the dynamics for Haverhill and many new Councillors. The fact they have not been given a chance to meet is unfair and to scrap HAWP based on a particular view of past performance without at least one meeting of the new Councillors appears dismissive of the value of their views and the wishes of elected Members.

To conclude, the Town Council believes HAWP should be given a chance to operate for a trial period. Once the current Councillors have formed their opinion, let the question be asked again. **RESOLVED**

C15 <u>Mayor's Report</u>

/128 Mayor McLatchy read her report to the Council, on her work as Mayor during the last month. (see appendix 2)

C15 <u>Parish Handyman</u>

/129 The meeting considered the report and proposed job description and budget for this role.

After discussion, it was agreed that although the work to be undertaken is the responsibility of other councils, it is clear that in order for a prompt response to issues not regarded as a priority by others, Haverhill will have to look to itself to do the work. It was proposed by Cllr J Burns, seconded by

Councillor D Roach, that the proposal for employing a parish handyman and leasing a vehicle for a period of one year be approved. **RESOLVED**

a) Appeals Committee

The meeting noted that the Appeals Committee had not met since the last meeting.

b) Finance Committee

It was proposed by Councillor J Burns, seconded by Councillor P Hanlon, that the minutes of the meeting held on 15th September be adopted. **AGREED**

It was proposed by Councillor P Hanlon, seconded by Councillor P Fox, that the minutes of the meeting held on 8th September be adopted and that the council agrees to act as Custodian Lessee on behalf of the proposed Pump Track site.

The meeting noted that the Personnel Committee had not met since the last meeting.

e) Planning Committee

It was proposed by Councillor P Hanlon, seconded by Councillor Q Fox, that the minutes of the meeting held on 8th September 2015 be adopted. **AGREED**

The meeting noted that the report was clear, there were no recommendations for action and that the Notice of Conclusion of Audit had been on display from July until September. It was proposed by Councillor M Byrne, seconded by Councillor J Burns, that the external auditor report be accepted. **RESOLVED**

C15 <u>Staffing Matters</u>

/133 The Clerk drew the attention of the meeting to the report on the minimum wage rates from 1st October. It was proposed by Councillor M Byrne, seconded by Councillor P Fox, that the following rates be adopted: Apprentice rate: £1 higher than the national rate, so £4.30p/h That the under 18 National Minimum Wage rate is not used. But that all

workers under age 21 who are on the NMW be paid £5.30p/h That the 21+ rate is not used, but that all workers aged 21 and over who would otherwise be on the NMW be paid the National Living Wage set by the Living Wage Foundation, currently £7.85. **RESOLVED**

Appendix 1

Reports from the Police, District/County Councillors on issues pertinent to Haverhill and the Public Forum.

Police Report:

Inspector Ferrie:

1. The change in the way crime is recorded has produced figures greatly increased on those reported last year. Some of it may or may not be actual increases in crime, but it appears to be mostly down to the change in reporting. Total crime has increased to 1215 for the year, compared to the three year average of 849. There are a few crimes that are reducing in terms of reports – drug related crime is down from 48 to 29.

2.Your Police teams in Haverhill (both response and SNT) are all currently fully staffed, with no vacancies.

3. The budget cuts for policing are looking to be between 25-40% cuts nationally. It is not yet known what this means to Haverhill. The government will announce the final figures in December.

4. In reference to the report regarding the skate park, the police find it well-used and there are no problems.

County Councillor Julian Flood:

Councillor Flood reported the following matters:

- 1. He attended a meeting of the Parkway Residents Association and found it very useful. He urged other Councillors to support their local Resident's Association.
- 2. He is funding new fishing stands at the "newt pond".
- 3. Wind turbine at Nosterfield End he understands has been rejected at appeal.

County Councillor Tony Brown:

Councillor Brown reported on the following matters:

1. Very disappointed to report the Sainsbury's pedestrian crossing now won't be installed until after Christmas

Mr W Austin: Expressed his opinion that ONE Haverhill's Masterplan report did not include the views of ordinary people given at the information days held on Market Hill. The fact the group refuses to meet in public takes away the democratic rights of townspeople.

Appendix 2

Mayor's Report for July – September 2015

Because of limited time this evening, I will highlight just a few of the many duties I have performed on behalf of Haverhill in the last few weeks.

On the 12th July I attended the local Vehicle Rally here in Haverhill and was very impressed with the way it was organised. The owners of the vehicles entered were very enthusiastic about his event continuing and even growing larger, they think it is one of the best venues in the calendar and our team here in the Arts Centre can be thanked for the smooth running of this event, if it were to be bigger it would need to be somewhere other than the car park and I certainly think this would be worth it.

On the 17th July we attended ONE Haverhill Apprenticeship Awards, this was very inspiring as the amount of work put into the by Karen who is based here at the Arts Centre, has led to local companies investing in a good number of apprentices in Haverhill. On the same day we attended the Leavenheath Civic Reception. In the same week we attended the ever popular and successful Haverhill summer bash again successful thanks to our Arts Centre Team, that evening we also attended the Mayor of St Edmundsbury's Civic service. That week we also attended an event put on by the amazing group, Inspire Suffolk Prince's Trust Team, I felt humbled by the success of the team in inspiring a number of our local young people to overcome difficulties and gain skills while in this scheme and I felt so proud of them as they stood up and described the experience of completing the course.

On the 28th of July we put on a Mayor at Home Event and I had the bright idea of doing something a little different to the usual glass in hand do, this was to put on a show of some of the terrific things we have in Haverhill and we only had about three days to do it, this meant a lot of hard work for Colin, Vicky, Nick and all the team here. You should have seen the canapés handed out they were made by our team here and were fit for a palace function. The theme was the Past, Present and the Future of Haverhill, in a very short time we managed to put on twelve displays related to this and it was very successful and still talked about on the Mayoral circuit, I am very proud of that event, it lead to Haverhill being described as the lost jewel in the crown of Suffolk, well, it is no longer lost as people are becoming more and more aware of Haverhill and we all need to make sure we promote it to the best of our ability.
