Report re item 6

Currently, Hartseats is being reviewed along with the operation of the Arts Centre, to make Hartseats less unprofitable.

We need to agree a charge to propose levying, by Hartseats, for the provision of a working bar and café to service the visitors and staff requirements of the Arts Centre.

I want to keep it as simple as possible to identify and to administer, so we can easily identify it in the books and put it to one side when examining the business performance of Hartseats. This is basically a rolled up annual charge levied in March for the preceding year.

The proposal is as follows:

£300 a week amenity charge for the provision of a café for Arts Centre visitors and staff, including facilitating refreshments at meetings for room hirers.

£200 a week amenity charge for the provision of a theatre bar to service evening performances and council civic events.

That would be £26,000 a year.

Given the Trust charges Hartseats rent and we recharge the cost of staff, Hartseats is currently trading without subsidy and is not charging for providing its services, taking all the risk that it can make a profit despite the limitations of working in this environment. This is not a real-world scenario. To supply a café and bar, £26k doesn't seem an impossible charge for services rendered.

Members will be aware that the Council already grants the difference between what it costs to run the Community Trust and the combined income of the Trust and Hartseats. So the loss made by Hartseats comes out of the Community Trust at the moment. This proposed charge will simply reduce the grant by the same amount.

This payment means Hartseats remains solvent.
