# HCT <u>Hartseats charge for the provision of catering services to Haverhill</u> 17/06 Town Council

It was proposed by J Burns, seconded by A Brown that Hartseats charges an amenity charge to the Council for the provision of Hartseats Café and bar for the benefit of clientele at the Arts Centre, at a rate of £300 a week for the café, including facilitating meetings and room hire and £200 a week for the provision of a theatre bar to service performances and events. This would be a charge of £26,000 for 2016/17. The price would be reviewed in subsequent years.
