c) Bee-friendly bus station. The Town Clerk reported that a discussion with Damien Parker and Simon Collins ascertained that loose-walled log bug hotels are easily vandalised. However, a developer has produced an environmental impact assessment which gives ideas for bug hotels, including sinking a longer log vertically into the ground. Damien and Simon agree this is a practical solution. The arboriculturist at WSC can provide the logs and also supply Castle Manor with logs from East Town Park if they would like to build their own bug hotel.

- d) Further plots for bee-friendly planting. The Town Clerk shared the document 'Landscaping Enhancements, Haverhill' (Appendix 2). The document identifies small pockets of land which could be used for biodiversity projects. It was agreed that low-level fences that prevent vehicles from accessing the land must not be removed. There are also opportunities to replace hedging that is missing.
- e) Parking on grass verges. This issue was resolved along Recreation Road by creating a bund with planting of wildflowers to replace the grass verges. An alternative is to create hibernacula which provide interesting habitats and stops people from parking on the verge.
- f) Bergamot Road (near Sainsbury's). The Town Clerk has suggested to WSC that they plant a native hedge line close to the steel fence that runs along the road. Once the hedge is established, the fence could be removed. This will create habitat for wildlife and still be an effective barrier against parking.
- g) New Croft has an issue with parking on the grass. This long stretch of land could become a biodiversity project and prevent people from parking there.
- h) 'Adopt a bed' scheme. Setting up such a scheme could provide an opportunity for schools and Tree Wardens to become involved.

#### Haverhill Tree Warden Group

We are writing to introduce ourselves as The Haverhill Tree Warden Group, which was formed in July 2021 by the Haverhill Town Council and is part of the <u>Suffolk Tree Warden</u> <u>Network</u>. Since then, we have been working alongside the Town Council over to find potential sites for planting trees in and around the town.

In January 2022, we were allocated a piece of land for tree planting by West Suffolk Council, at the skate park area off Howe Road and we planted ten oaks trees to commemorate the Queen's Platinum Jubilee as part of the Queen's Green Canopy. The local park rangers assisted us with this planting, with permission from Christine Williams.

Unfortunately, these trees were vandalised during the summer holidays in July 2022 and suffered through the extreme heat and there are now only two of the ten remaining on that site, which is a great disappointed to us.

We would very much like to find additional suitable sites for more planting in and around the town and would like to work with Haverhill Town Council, West Suffolk Council and local landowners to achieve this. We have approached Havebury Housing Association to enquire about potential planting sites, but we have not been able to progress this very far with them due to lack of interest on their part.

We have noted in the Report of the West Suffolk Environment and Climate Change Taskforce: Environment and Biodiversity Emergency in West Suffolk (CAB/WS/20/046 – 21 July 2020) the following section:

'2.8 Utilise, and where necessary support partners to engage in green improvements schemes e.g. Park Friends of groups, and other voluntary organisations. Rangers will host volunteer events at Nowton Park, East Town Park & Brandon Country Park. Within Existing budget Within existing allocations Within Existing Budget Improved awareness Budgets not decreasing.'

As a group, we most definitely fit the criteria of wishing to protect and improve the biodiversity of our local area. One of the good things about living in Haverhill is that we have a lot of trees which really enhance our locality and the health and wellbeing of its residents, but we are concerned that the new building sites do not provide enough trees that will grow above the rooflines, and that there is not enough planting happening to replace and renew trees within the town itself for the future. Many of the flowering trees planted along our streets have not been replaced over the years and this is very disappointing.

The current planting season is from November 2023 to March 2024, and we are in the process of trying to find suitable planting locations. Our experience of tree vandalism has made us very cautious about where we plant in the town, so we would be grateful for any guidance, experience and support you could offer us.

We would be delighted to hear from someone within your Biodiversity Taskforce team.

### Landscape Enhancements, Haverhill

### Purpose of the report

The District Council applied and was successful in receiving a grant from the Rural England Prosperity Fund (REPF) for certain green enhancement projects to the amenity areas it is responsible for in its rural towns.

The district is now seeking the Town Council's support and feedback to progress the year one projects in Haverhill which it hopes to complete by the end of March 2024.


Whilst there is a tight turnaround on the delivery of the project this year officers will make contact with the local schools to see if there is any opportunity to involve them in a community planting event.

The urban extension to the west of Haverhill during the 1990's included a significant amount of open space required as part of the planning process.

This open space included a number of small incidental open spaces that included seating, bins and tarmac paths that where then surrounded with timber knee rails.

As these smaller areas have matured and maintenance practices have changed, they have become more difficult to maintain effectively.

We are therefore looking to redesign five of these spaces as shown highlighted in blue below by incorporating them into the wider landscape and using this opportunity to improve the biodiversity.



All the locations will have their excess tarmac paths removed but retain any main footpath links that already exist. Benches and bins will be reviewed, and positions modified to better suit the locations.

All soft landscaping reinstatement will use a species rich lawn seed mix and where practical native shrub planting. The species rich lawn mix will also allow for a more flexible mowing schedule.

Further ecological improvements will be encouraged where these can be delivered in partnership with external partners.


