- c) A survey be undertaken regarding support for public services delivered and levels of funding required by the Town Council
- d) The Finance Committee undertake detailed reviews of budget lines
- e) Groups receiving Town Council grants attend an annual meeting to

- outline how the monies received contributed to the well-being of the town
- f) Until the outcome of research into levels of support for existing services is known, the Arts Centre Working Party be disbanded
- g) The Borough Council Cabinet Member with the Haverhill Portfolio be invited to attend and speak at every Full Council meeting
- h) The Personnel Committee receive a full report on current staffing, including job descriptions, salary banding and sample working rotas
- i) Suffolk County Council be advised that, in considering greater devolution of powers, funding and management, the priorities for consideration by the Town Council are:
 - a) services to youth, particularly youth club, detached youth worker, and existing youth provision
 - b) services to older adults, including day care support and provision, and Community Transport
 - c) management control of Community Centres, including the Burton Centre and the Chalkstone Centre
