

#### C14 **West Suffolk Shop Front Design Guide**

/115 The Council considered the draft guide which was out for consultation, closing date 9th January. The purpose of the design guide is to provide guidance to improve the general standard of shop-front design and advertisements throughout West Suffolk and an understanding of the design of shop fronts and advertisements that the local planning authorities in West Suffolk will support when reaching a decision on any planning application or application for advertisement consent.

> Whilst the Council was against regulations which stifled the vitality of Haverhill High Street, which is already vary varied, it was agreed that the principles of the document were worthy of support.

The Clerk was asked to draw up a draft response for consideration at the **CLERK** Planning Committee on 6<sup>th</sup> January 2015.

### C14 2015/16 Annual Budget

/116

The Clerk presented the details of the 2015/16 draft budget, which had been before the Finance Committee and Personnel Committee. It was noted that the Council Tax Base had been amended by SEBC directly before the meeting, too late for the additional revenue to be taken into account.

Subject to the above amendment, it was further noted that the 3-year budget prediction identified that whilst it was looking possible to keep the band D rate of £111.75 frozen for 2015/16, the prediction was that a significant increase (4.8%) would be needed in 2016/17 to cover the removal of the Council Tax Support Grant. In 2017/18 a 2% uplift would be required. However, the Clerk advised caution about putting too much store in those predictions, given the changes in tax base that could occur as Haverhill expands.

The Budget was noted. The Council will make the final decision on the budget and precept at the next meeting.

# C14 One Haverhill

- days a) The Mayor reported that the Town Centre Masterplan tenders have been received and a provider selected, subject to the normal post-selection procedures. All the tenderers were subject to pre-qualification assessment so all are very capable of delivering what is a complex and extensive piece of work. The cost is £60k, of which the Town Council is asked to contribute £20k. Other parties, including both principal councils, are also contributing.
  - b) The Clerk reported that a meeting with Suffolk County Council had been arranged for early January regarding the Old Magistrates Court. Securing their co-operation on the Town Council's acquisition of the building on terms that keep the project viable is key.

# Appendix 1

Reports from the Police, District/County Councillors on issues pertinent to Haverhill and the Public Forum.

# **County Councillor Tony Brown:**

- 1 The damaged railings outside Aldi have been replaced.
- 2 Councillor Brown can provide from his Highways budget a Vehicle Activated Sign system for Haverhill Police SNT to use at various speeding hotspots around the town. Two PCSOs have offered to do the training associated to operate it.
- 5 Councillor Brown has been chasing for the date of the installation of the new signage for the High Street, having originally been told 8 weeks from when the survey was carried out, which was about 8 weeks ago. Since then he has been asking for a firm date which has not been forthcoming. He has tabled the question to be asked at the SCC full Council on Thursday. He hopes to have an answer then.

Cllr Robbins advised the meeting that the new signs were being erected today.

## **County Councillor Julian Flood:**

- 1 Cllr Flood met with the CEO of the County Council in an attempt to persuade her that SCC should invest in social housing.
- 2 He has put a question to Councillor Newman regarding why School Lane is not yet resurfaced.

## **PCSO Sophie Mitchell:**

Firstly apologies for the absence of Inspector Ferrie, he has asked myself and my colleague Mark Isaac to attend this evening to provide a short Police report to the Town Council. Unfortunately we do not have the comparative year on year percentages however we have a list of crime figures for the Town since the last meeting.

Since the last Police Report provided to the Town Council on Tuesday 25th November, there has been 86 crimes of note in the Town, broken down these were:

- 19 Incidents of Criminal Damage
- 3 Arsons which are part of a series of 5 we have seen across the town, which are currently being investigated and we are working closely with the Fire service to tackle these incidents.
- 16 Burglary other buildings There was an overnight series of shed breaks which occurred on one single road in Haverhill and make up the majority of these offences.
- 8 Burglary Dwellings
- 13 Theft from shops a large number of these were committed by the same offender who has since been arrested and dealt with.
- 6 Theft from motor vehicles
- 5 Theft of pedal cycles This is a current trending spate in which case all cycles were left insecure in front gardens to properties, we would like to stress the importance of leaving pedal cycles locked and secure at all times when unattended.

- 14 incidents of Assault
- 2 Drug Offences

## Mr John Burns:

Mr John Burns drew the meeting's attention to the work of PCSO Kayla Packman, who has worked hard to prevent the thoughtless and inconsiderate parking in the High Street. She has issued 500+ tickets since she started, but has been subjected to abuse and physical violence.

The Council voiced their support for the work she did.

## **Mr Gordon Savory:**

Asked that the Council make a stand that the High Street is a restricted area and to stop traffic entering it, as is achieved in Queen Street.

**The Mayor** responded that the matter of pedestrianisation was part of the masterplan consultation. Some businesses object to the idea of pedestrianizing the high Street so the Town Council will press for a sensible solution.
