C25 Reports from District/County Councillors on issues pertinent to /155 HAVERHILL and the PUBLIC FORUM

a) Police Report:

Inspector Matt Paisley introduced himself and John French, Modern Slavery Advisor. Inspector Paisley and John French updated Members on the operation that had taken place recently on premises in Haverhill. He advised the council that John French's role is to identify victims of slavery, that is those who have been coerced into activities against their will, are underpaid and living in poor living conditions and to identify those who are putting these individuals into work and who may or may not be part of a larger criminal organised group.

In answer to a question, Inspector Paisley explained that members of the press were present on the day of the operation, local press, Sky News and the Telegraph.

That operation was one of many conducted across the country and they will be repeated in the future. The operation was highly successful, due to working in collaboration with the community and other partners. Such operations can sometimes attract negative perceptions, particularly when premises are identified publicly, but emphasised that the police and partner agencies will tackle any premises operating illegally. The work extends far beyond what is found on the day and includes examining ownership, tenancy, financial arrangements, immigration status, and potential links to wider organised criminality. The operation was collaborative, involving partners such as the National Crime Agency, the Fire Service, local authority teams, and Immigration Enforcement. The aims were to safeguard vulnerable individuals, protect the public, and educate communities about the wider issues of human trafficking, exploitation, illegal working, counterfeit goods, and unsafe trading practices. Communication with the public had been well received, and press coverage had helped address misconceptions around immigration by highlighting the realities of modern slavery and human exploitation.

In response to a question about why the businesses in question were allowed to continue operating, Inspector Paisley explained that the police have limited specific powers to close premises, but closure decisions often fall to other lead agencies depending on the circumstances. Investigations

can take time and resource, but intelligence about any premises remains under continual review.

Three local premises were found to have people living on site in unsafe conditions. All were revisited by the Fire Service and local authority housing enforcement; one has since received a prohibition notice, and the others have sealed off areas previously used for accommodation. Ongoing checks will continue. One premises was found to have an illegal worker, and Immigration Enforcement is pursuing a civil penalty referral notice, fines of up to £65,000 per illegal worker, part of a wider countywide approach that has so far resulted in nine notices being issued.

Inspector Paisley also addressed concerns about victim welfare and explained that support is offered through the National Referral Mechanism where individuals consent, and a "duty to refer" applies even when help is declined. Victims are provided with information on how to seek assistance in future, recognising that many have experienced trauma or distrust of police in their home countries. Specially trained Victim Liaison Officers are deployed on all operations to provide immediate support to vulnerable individuals.

Appendix (i)

Ambulance response times statistics report

Although it might be unreasonable to expect C1 response times in Haverhill to equal those in Cambridge, the contrast between Haverhill and Cambridge is informative:

We should remember that the 90th percentile is the minimum response time for the greatest 10% of response times. It does not tell us how long the longest response times were. To see any improvement over time, the following table extends the contrast between Haverhill and Cambridge over the last three 12-month periods:

The large gap in C1 90th Percentile performance has not significantly reduced. The most recent 12-month period shows a small but welcome reduction of the gap in C1 Mean performance, but we should remember that:

- The gap in C1 Mean performance is still an extra 5.8 minutes.
- In only eight out of the 46 months since the beginning of 2022, has Haverhill's C1 Mean been less than Cambridge's C1 90th Percentile.

¹ Monthly C1 response time statistics fluctuate as a result of seasonal variations in weather and infectious diseases, particularly for Haverhill, which has a much smaller number of C1 incidents each month than Cambridge. So, a good statistic is a rolling 12-month average.

2. Relief Road

The relief road is open and continues to be well received. The signage is now up, though Persimmon are waiting sign off from county on the Lorry route signs. Heras Fencing is not functioning as intended. Speed data is being analysed and a decision will be made regarding whether to keep or remove the Hera Fencing.

3. Highways Update

Haverhill Town Centre Signs & Ehringhausen Way
 Signs have been ordered and the order is now with M Group (previously Milestone) – awaiting installation

• <u>Allington</u> Walk

This road is still scheduled a resurface but has been pushed back to February – No further update.

Bypass/ A1307 cutback and signage issues

Both Cllr Roach and I have continued to lobby for additional funding to prioritise a cutback. This has not been an easy discussion as there are similar issues across the county, and the issue is not just restricted to Suffolk. We have offered Highways locality funding to help get this overt the line and I hope to have an update for the December Town Council meeting.

4. Active Travel, Cyclists, Pedestrians and Rights of Way

• <u>Haverhill Local Transport Plan</u>

I again made representations to officers given to me from Town Councillors comments following discussion last February. The HLTP is progressing and officers are identifying projects for delivery across the Town. When I have more, I will share.

New Pelican/Toucan Crossing on Wratting Road

This is progressing well, though still no date for the installation.

Consultation on Raised Table on Ann Suckling Road

A consultation has been taking place for the raised table crossing point on Ann Suckling Road. This is something I have lobbied Highways and Persimmon for the last 4 years, based on concerns raised to me by residents. This raised table will act as both speed mitigation and providing a safer crossing point from the Persimmon development to the Boyton Hall Estate. I am awaiting the outcome of the consultation from officers.

• <u>Greenfields Way dropped Kerbs & Path from Clements School to The Doctors Surgery (Bus Stop)</u>

Still awaiting notification of an installation date. It had been paused due to other planned works on Greenfield Way. This has no been lifted but is still likely 12 weeks away from delivery.

• Bus Improvement Scheme

Carried out public engagement on RTI boards for the bus station and passed on to officers at SCC. Proposal endorsed by Cllr David Roach & myself. Some technical hurdles remain but I am hoping that an announcement can be made in the months ahead. Representations have been made for improvements to Bus Shelter infrastructure for Chivers Road and Chimswell Way.

5. Haverhill Library Toilet

No further update – awaiting S106 monies to be released to fund the Toilet project. Persimmon are now very close to 500 occupied units triggering the release of funds. Awaiting confirmation so that monies can be released for works to commence.

6. Widdington MRF Planning Application

This is now slated for Decembers Development & Control meeting. My intent is to attend and speak on this application when it goes to committee. I would welcome representations made to me by local members that I can share on your behalf.

7. Ambulance Service and Response Times in Haverhill

I have spoken with the new Chair of the committee Cllr Liz Harsant and I plan to speak at the public Questions part of the next meeting in January. I have emailed Cllrs Stinchcombe and Cllr Brown seeking guidance on what they would specifically like raised. I am happy to receive representations made by other members.

8. EV Charging Installations

Believ, who are currently integrating the "A" sites that haven't already been looked at into their survey programme. Meanwhile Ash Grove is still likely to be the first installation. There has been a slight delay as SCC had to approve some additional funding to subsidise this one, as the grid connection cost came back higher than first quoted. It is not therefore going to be in the sites installed this side of Christmas; however, it will be in the first build batch of the New Year. I was consulted by officers on further representations from Cllr Alan Stinchcombe relating to some additional roads to be considered, which I was happy to support.

We have had positive feedback with Havebury Housing Partnership last week and shared the locations on the list where it was thought they might be the landowner for their feedback. They are keen to help and are already surveying their tenants to ask who owns an EV – It has been explained the project is about future proofing as well as meeting existing demand.

Regarding the Leiston Road car park – West Suffolk Council have confirmed which areas of this site they own and are happy for us to progress to survey; they own the side that is adjacent to Harewood Terrace and so Believ has been asked to look there first.

I am awaiting details from County regarding which roads will be confirmed for the first phase of installation.

9. Banking Hub Cash Point

As I am sure you are all now aware, the external cash point has now been installed on the High Street, which is a major step forward after the long delays we've all been hearing about from residents and businesses. Although the unit isn't yet switched on, the final technical checks are underway and I'm continuing to press Cash Access UK and the Post Office to get it activated as soon as possible. The lack of out-of-hours cash access has been a real frustration locally, so it is good to see this finally getting this over the line.

I also want to acknowledge the role of the late Michael Simpkin, who was instrumental in pushing for the Banking Hub in the first place. He approached me with detailed research back when the idea was still new nationally, and his determination helped Haverhill become the first permanent banking hub in Suffolk. With the cash point now in place, we are close to finishing what he set in motion.

10. Persimmon & Havebury (Landscaping & Maintenance Issues)

Recently I have been quite publicly critical of both Havebury and Persimmon regarding landscaping and maintenance. Havebury to their credit responded quickly by improving the landscaping around Saxon Close (Off Ann Suckling Road) I have submitted a detailed report to West Suffolk Planners and Persimmon relating to issues still present on the estate. I have a meeting planned with Persimmon in the new year where I am hoping much needed progress can be made.

11. Blue Lights Hub

After some extensive lobbying and work with Nick Timothy MP & Tim Passmore PCC and meeting with key Stakeholders from the Police and Ambulance Service, it would appear this is slowly gaining momentum. West Suffolk Council are now engaged and a meeting is currently being planned for the coming weeks. Hopefully this will continue to progress and I look forward to seeing whether finally this can begin to progress. It is very early days and might not come to fruition. But discussions are taking place, even if it is just currently at a discussion stage with key stakeholders, which hopefully will eventually lead to a more concrete proposal.

• Haverhill Town Centre Enhancement Group

WS Cabinet Planning has agreed to begin three quick-win projects aimed at making the town centre more welcoming and strengthening its identity. These projects reflect stakeholder feedback and will deliver visible improvements while supporting longer-term ambitions.

The three projects are:

- Wayfinding: replacing outdated and inconsistent signage with a clear, unified system that improves accessibility and reflects the town's character.
- **Public Realm Lighting:** improving lighting to make the area feel safer and more inviting, particularly in the evenings.
- Street Furniture Renewal: updating worn or mismatched benches, bins and other features with a coordinated set that improves the look and feel of the streets.
 Together, these projects mark an important first step in refreshing the town centre. Initial design work will focus on Queen Street, Peas

Market Square, Market Hill and the main High Street gateways. The Steering Group has been thanked for its continued support and contributions, which have helped shape the priorities to date.

Next, the team will:

- Work with the town council to involve the public in the design process through local arts groups.
- Establish a Town Centre User Group, drawing on feedback from the recent benchmarking survey.
- Engage with community groups, forums and local businesses as designs develop.

Work is also under way to explore development opportunities at Jubilee Place, building on last year's £2m investment in Provincial House to support jobs, improve

access to services and increase footfall. Ideas for Jubilee Place are being informed by survey feedback and early discussions with developers, reflecting changes in town centres since the 2015 masterplan.

The team will continue working closely with the Steering Group as the project develops, with the aim of producing concept designs that can attract further investment into Haverhill town centre.

I remain frustrated at the lack of progress and slow delivery of High Street improvements

13. Community

- a. Burton Centre Court Announcement has been delayed and will now be end of December/January
- b. Burton End Camps Road Maintenance. Many thanks to the Town Council Wardens who have completed works on Burton End including cutbacks and the painted railings. I can see across town the impact the community wardens are having.
- c. Burton End Windmill & Clements Estate Shopping Plaza Makeover. I have been approached by a local landscaping business and put in contact with the Town Council and Havebury regarding improvements to the areas. Hopefully this will progress.
- d. I have attended a number of meeting and engaged in community liaison with the Police. I attended a CAP (Community Action Partnership) meeting with PC Jack Oakley and other stakeholders across the town. CAP sets up and supports local partnerships that aim to reduce alcohol harm in children and young people, improve their health and well-being and enhance their communities. Surveys have gone out and the local community police team are planning a second meeting with updates on what is being planned over the next months and year.
- e. PC Jack Oakley contacted me regarding a Christmas campaign asking people not to purchase e-scooters and e-bikes, which I was happy to support.

Report by Cllr John Burns on Town activities November 2025

Police Matters: Crime stats for September 2025 were distributed on 8th November. Not much else to say as police due to attend the meeting.

SCC Highways: I understand the new signs are being built and due to be installed by no later than early 2026.

Parking: I am not seeing any benefit from the so-called increase in enforcement. Vehicles parked for hours in the High Street, without any reason, as well as in the loading bay alongside the Market Square. In meantime it seems those popping into the Doctor's or Pharmacy in Camps Road are being over penalised when they are not creating an obstruction or endangering pedestrians.

Markets: Still awaiting another meeting.

Vixen PH (Millfields Way): No further information. Yet another local resident fell on the steps leading from the car park to the Square damaging their elbow. I have reported this to the planners who escalated to the relevant lighting teams but there is/was no problem with the lights. The steps are owned by the owner of this property and have been reminded of their obligations. I have recommended, as such a vital part of the walkway from the Chalkstone Estate to town, that WSC should take ownership and maintain them considering they own the land in between.

Strasbourg Square: See above.

Other work:

- Worked the entire day until late at night on the Halloween Trail.
- Took up & collected from New Croft barriers for Rovers' firework night.
- With others helped organise and execute the annual Remembrance Service.
- Attended meetings regarding LGR and possible Community Alcohol Partnership for the town.
- Helped with installation of the Xmas tree.
- Currently setting up 5 x new computers for the Tech Office systems. Supporting other systems.
- Provided usual weekly financial income stats from the till system for the various sites to HTC management plus attending various HTC meetings.
