# **Overall Responsibilities**

a) To work with the Senior Youth Worker to provide outreach services to young people using the On The Spot Van.

- b) To work with the Senior Youth Worker to provide detached youth work services to young people:
- c) To work within a building to provide informal education in a safe and welcoming environment.

## **Specific Responsibilities**

- 1. To work with other Youth Workers to provide outreach services to young people using the On The Spot Van:
- a) Visit sites identified by the Senior Youth Worker, Youth Action Group or Suffolk Constabulary as places of interest in respect of youth activity.
- b) Ensuring that Health and Safety procedures set by the Senior Youth Worker are implemented fully and completely.
- c) Accurately recording attendances, locations, actions, events and issues on a confidential session sheet.
- d) Providing a listening ear to young people.
- e) Deal with general enquiries from members of the public
- f) Reporting any incidents or issues, equipment problems or concerns of risk promptly, to the Senior Youth Worker or your professional supervisor.
- g) Reporting safeguarding concerns promptly following the Suffolk Social Care Safeguarding Protocols as adapted for the project.
- h) Check the On The Spot Van before and after each use to ensure it is safe and roadworthy.
- i) Ensure the security of the van at all times.

- 2. To work with other Youth Workers to provide detached youth work services to young people:
  - a) Specific responsibilities a-g above apply to detached youth work.
  - b) Visit locations on foot where it is not practical/advisable to take/leave the OTS van.
  - c) Agree aims and strategies with the Senior Youth Worker before engaging groups of young people.
  - d) Ensure your own security and safety and that of your colleagues at all times.
- 3. To work with the Senior Youth Worker to provide a youth club or indoor/outdoor activity to young people:
  - a) Ensuring that Health and Safety procedures set by the Senior Youth Worker are implemented fully and completely.
    - b) Accurately recording attendances, actions, events, and issues on a confidential session sheet.
    - c) Providing a listening ear to young people.
    - d) Deal with general enquire from family members and carers.
    - e) Set up and put away equipment.
    - f) Reporting any incidents or issues, equipment problems or concerns of risk promptly, to the Senior Youth Worker or your professional supervisor.
    - g) Reporting safeguarding concerns promptly following the Suffolk Social Care Safeguarding Protocols as adapted for the project.

## **Other Duties**

- 1. To attend meetings as required by the Management.
- 2. To act as a good ambassador for the Council.
- 3. Undertake and training as required to enable you to do a broader range of duties within your personal capability.
- 4. To carry out any other duties as might reasonably be required within the general orbit of responsibilities of the post.
