**P16 /034 Minutes of the Previous Meeting**

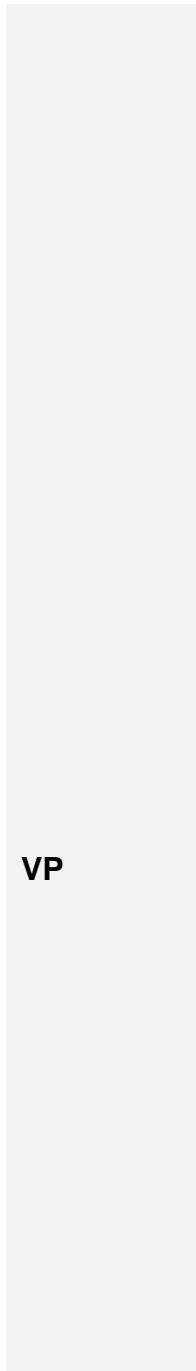
